M.1 Call to order, welcome

The meeting was called to order at 7:00 pm.

M.2 Adoption of agenda

The agenda was adopted as circulated.

M.3 Adoption of previous minutes (October 30, 2012)

The previous minutes were adopted without change.

M.4 Administration update

CTV News did a piece on overcrowded schools. Irene Atkinson provided a tour with K.Wylie and A. Violi (parents). The piece worked out well.

Today Mr. Kite's retirement was officially announced.

Report card period went very well.

Elementary teachers will be in strike position as of Dec. 10th. An outcome of this is that we are having musical presentations during the day, as opposed to concerts. In addition, activities that link to the Ministry of Education will also be impacted eg, sports teams, field trips. Runnymede is maintaining a positive attitude. There has been contingency planning for the Quebec trip in December and that trip is currently under consideration. And there has even been some initial planning to ensure the graduation celebration goes ahead at the end of the year, even if teachers cannot attend.

M.5 2012-2013 Budget review

A copy of the Profit and Loss Budget was circulated (see attached). So far we are ahead of budget. We anticipate being ahead by \$5,000 at the end of year if all funds come in

according to plan.

The field trip bursary funds are not currently being used. We will hold them for now, but at a future point in the year if it looks like there will be no field trips, we may consider reallocating those funds.

M.6 Committee updates

Written updates were circulated with the Agenda. A question was raised for the Communications Committee regarding a process for ensuring that all Ward 7 and broader meeting notices get sent to the parent community, and a discussion about streamlining the rapport so that it is shorter and more regular (monthly).

M.7 Pursuing grants

J. Marrie volunteered to help identify grant opportunities that fit with the school's initiatives.

M.8 Update on pedestrian crossings on Runnymede Rd. (north and south of the school)

M.9 Ward 7 updates and council working session

M.9.1 Repair work currently underway at Runnymede PS

Two issues we are trying to bring forward are overcrowding and state of disrepair. Letters have been sent to the Minister of Education, Chris Spence, and various individuals within TDSB who were identified by Trustee Atkinson.

A. Dennis met with a Facilities Supervisor immediately following the letters being sent and several repairs were undertaken: wall plastering, washrooms painted, a carpenter has put up pictures, safety mats were installed in the senior gym, a leak in the roof was repaired, tiles in the kitchen and basement were replaced.

Adventure Club asked about a point in the letter alluding to rumours that the after-school program might leave the school, and this was explained as a "worst-case scenario" possibility.

Other items on the list of things in need of repair included windows and new soap dispensers for the washrooms. A suggestion was made that an email be circulated to solicit ideas and observations from parents on other things that need repairing at the school.

M.9.2 Ward 7 updates and working session

H. Jordan provided background on the capital plan and why it was on hold by the Ministry. The Keele and Swansea additions being on-hold directly impacts our over-capacity issue.

The Ministry has given money to the TDSB for full-day kindergarten but the board put the money into the operating budget and it cannot be specifically identified.

The plans for additions to address over-crowding have been talked about for several years, and there is no money.

The only option left to address over-crowding here would be to bus children to another school. We have already had a PART, ARC, and portables. Swansea is already bussing kids in catchment to another school that has space.

The council moved into a brainstorming session about what we should and can do in light of this.
